Submit to your sponsor, who will either forward to Membership Chairperson, put in Clubhouse cash register, or drop in Harbormaster's mailbox. **YOU MUST SUBMIT ALL FEES & DUES WHEN YOU SUBMIT YOUR APPLICATION.**

3. After 25 days of posting, contact the Membership Chairperson to arrange for an interview. The interview must be completed prior to the Board of Directors meeting, to be considered for approval that Month.
